

SUMMARY OF EUROPE SAILINGS HEALTH AND SAFETY GUIDELINES



1. PREREGISTRATION AND TESTING

- Guests are required to complete the [Greek](#) and/or [Italian](#) government's passenger locator form (PLF), no later than 24-hours prior to arriving in to either country.
- After completing the PLF, a confirmation email and QR code will be sent to you for entry requirements.
- All guests arriving into Italy by any means of transportation are required to have a negative COVID-19 test (PCR or antigen) taken within 72 hours of arrival into Italy.



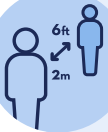
2. ONLINE OR NAVIGATOR® APP CHECK-IN

- Download the [Navigator App](#) and/or check-in online at hollandamerica.com.
- Complete Vaccine Attestation, Cruise Contract and Risk Acknowledgment form.
- Complete Pre-board health questionnaire 72-24 hours before check-in.
- Get boarding pass and check-in time.
- Please also review the [prohibited items list](#) prior to leaving home.



3. EMBARKATION

- Show physical proof of vaccination (required at entry).
- Show completion of risk acknowledgment and health questionnaire.
- At the cruise terminal, Holland America Line will administer a complimentary rapid COVID-19 test prior to embarkation.
- Additional health screening (as required).



4. WHILE CRUISING

- Through February 28, 2022, all guests will be required to wear face masks in elevators and in designated indoor entertainment areas, all retail shops, and in the casino, except when eating or drinking. Guests will be required to wear face masks prior to being seated in our main dining rooms and in the Lido Market area and occasionally in other designated areas where larger number of guests may congregate (signs will be posted).



5. SHORESIDE EXPERIENCES

- Holland America Line shore excursions are strongly encouraged.
- Independent activities are permitted for cruises originating in Greece or Italy.
- For our guests who have a mid-cruise port call in Italy, please be aware that the updated local requirements only allow "in-transit" guests who are participating on a Holland America Line shore excursion to go ashore. Self-exploration and independent tours will not be permitted. Any applicable change to the Shore Excursions Program in Italy will be advised prior to your sailing.



6. PRE-DISEMBARKATION TEST

- A complimentary antigen or PCR COVID-19 test will be administered to all guests on board on Day 5 or 6 of the voyage which can be used for disembarkation country requirements or for return home requirements.

Note: We recommend all guests take a viral test within 3 days of travel to avoid travel disruptions associated with a positive result.
